AGUA is a regional, grassroots coalition of impacted community residents and allied non-profit organizations dedicated to securing safe, clean, and affordable drinking water for the San Joaquin Valley.
- LA County - WHAM
Opportunities to coordinate among 4 measures: W-H-A-M. Measure W, approved in November 2018, will raise nearly \$300 million each year beginning next year for storm water projects. Measure H, approved in March 2017, raises approximately \$355 million each year for homelessness services and housing. Measure A, approved in November 2016, provides approximately \$100 million annually for new parks and park improvements. Measure M, approved in November 2016, raises about \$860 million annually for transportation infrastructure.
